The IARC classification was based on high concentrations of titanium dioxide particles in animal lungs. Under intended use of this toner product, exposure to titanium dioxide is much lower.  None of the other ingredients in this preparation are classified as carcinogens according to ACGIH, EU, IARC, MAK, NTP or OSHA.
