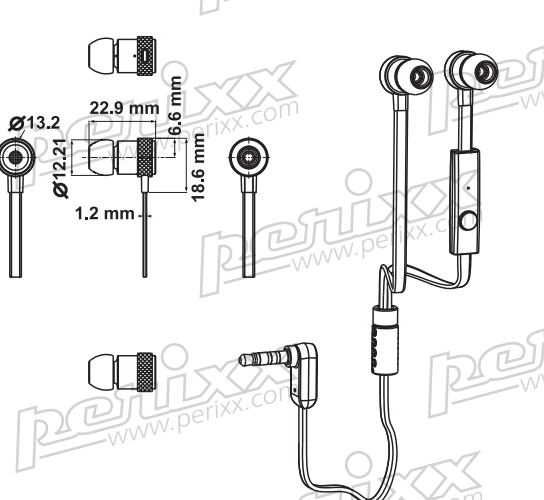
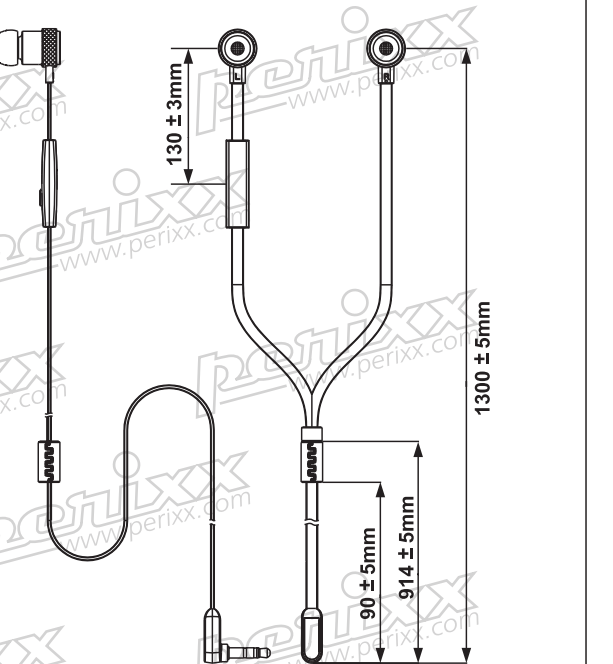
To avoid potential damage to the device, always disconnect all cables before transporting it.

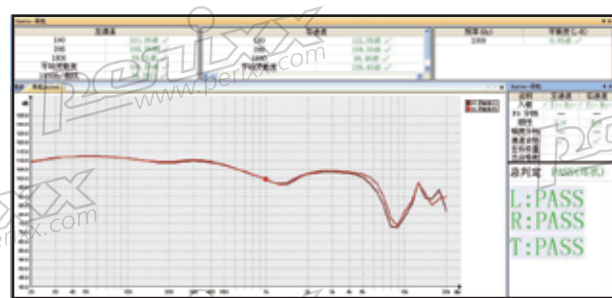
